Explanation and Instructions: In an effort to show members that their work and dedication to the ALR is held in the highest regard, we award the ALROH. The ALROH is the highest award that the ALR can give its members, therefore careful consideration should be given when nominating a member for this award. This award shows that the recipient has gone far above and beyond the call of duty for the American Legion Riders organization. By their dedication, drive, and determination they have helped make the American Legion Riders grow and prosper. A nominee shall have been a full member for at least 3 years. Only those people who have met these criteria should be nominated for this award.

Please fill out the information above and add a letter giving a brief biography of the nominee, their notable accomplishments, reasons why your nominee should be awarded the ALROH, and any endorsements from Chapter, Post, Department, etc. Each **Chapter** is limited to one (1) nomination each year. Due to this limitation, ensure this nomination is voted on by your Chapter and signed by a Chapter Officer before submitting.

Awards will be given at the rate of one winner per 100 Chapters. (Example: 899 Chapters 8 possible winners, 900 Chapters 9 possible winners...), though all available ALROH awards may not be conferred each year, as determined by the judges. The six month period for nominations extends from November 1st of the prior year through April 31st of the year in which the award is to be conferred. **Nominations must be mailed (no nominations by email will be considered) and must be postmarked between November 1st and April 31st as noted above. Late entries shall not be considered, nor held for consideration in subsequent years; entries received between April 31st and November 1st will be considered late. No notification/response will be provided for late entries.** Entries become the property of the ALR, and no materials will be returned.

Review and approval of nominees to receive this award is performed by past ALROH recipients. In the event no past recipients can be reached in time for voting, a committee of ALR members will be selected at random to determine recipients. Results of this process are final.
